A LOOK AT MISSION

More than 10,000 congregations, 170 presbyteries, 16 synods and the General Assembly Mission Council accomplish mission together on a larger scale than any of us could do alone. Per Capita pays for the ecclesiastical responsibilities and Unified Mission supports the mission and ministry of our presbytery, our synod, and the General Assembly Mission Council.

Unified Mission giving is a contribution, without restriction, that allows for presbyteries and synods to strengthen and support our connection to each other and helps grow the church deep and wide. It's a concrete way we follow in the footsteps of the early Christians as they formed the first church.

The Presbytery sets a recommendation ratio; however, local Sessions may set a different rate.

A LOOK AT PER CAPITA

Current Per Capita Apportionment:

2022 Per Capita as approved at the November 2021 Presbytery Meeting is:

General Assembly (GA)	\$ 8.98
Synod of Lakes & Prairies	\$ 5.50
Northern Plains Presbytery	\$ 33.52
Total 2022 Per Capita	\$ 48.00



The 2022 apportionment is based on a church's membership as of December 31, 2020, as reported in the 2020 General Assembly Statistics.

The Presbytery of the Northern Plains pays 100% of each member's Per Capita to the General Assembly and Synod of Lakes and Prairies as required by the Book of Order. The session of every church in the Presbytery is encouraged to understand their church's responsibility to help fund the greater work of the Presbyterian Church (USA).

History

Per capita payment began in 1755 as a means of equalizing the cost of travel of commissioners to meetings of General Assembly. The fund was raised by apportioning a fair share among the Presbyteries according to their numbers. Over the years, presbyteries came to raise the apportionment by asking each congregation to pay according to the number of members.

If the Presbyterian Church (USA) were a tree, per capita apportionment would be the nutrition used to provide for the roots (General Assembly), the trunk (synod), branches (presbyteries), and leaves (congregations) to remain healthy and connected. Each part of the tree is crucial for the survival of the tree. Each congregational member's payment of per capita ensures the Presbyterian system can function on behalf of us all.

Figuring Per Capita

Per capita apportionments for a given year are based on the memberships of the churches two years earlier. The 2021 apportionment is based on 2019 membership figures from the annual report to the General Assembly - the most recent figures available when budgets are adopted.

Your Responsibility

Per capita is an opportunity for all communicant members of the Presbyterian church through the governing bodies to participate equally, responsibly, and interdependently by sharing the cost of coordination and evaluation of mission; and of performing ecclesiastical, legislative, and judicial functions that identify a Reformed Church, while at the same time strengthening the sense of community among all Presbyterians (GA Minutes, Part I, 1995).
